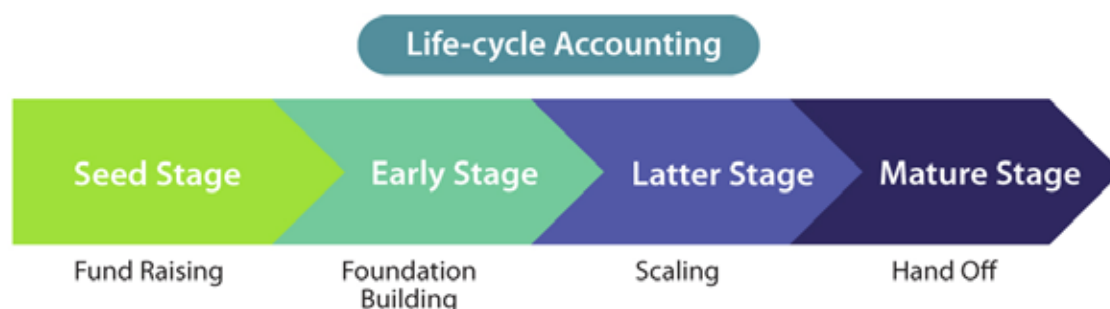
Management Profile
